# 4. Attachment B: Scope of work

Setting up an Early Warning & Action Mechanism on Community Resilience against Violent Extremism in the Bounkani region in Côte d'Ivoire

#### Context

Resilience for Peace (R4P) is a five-year USAID-funded, EAI-implemented, initiative to strengthen community resilience and learning, particularly for women and youth, to counter and prevent violent extremism in Côte d'Ivoire's northern border areas. Working with partners – National Opinion Research Center (NORC), Indigo-Côte d'Ivoire and Chaire UNESCO of Bioethics at the University Alassane Ouattara – the project will foster a "CVE ecosystem" by reinforcing community resilience structures, creating civic and economic empowerment opportunities for at-risk border communities, and through improvements in natural resource management and government-service delivery and responsiveness. Other activities will educate citizens and foster dialogue networks and townhalls to build whole-of-community trust, increase positive narratives, generate knowledge and learning among local communities on CVE concepts, while economic empowerment and positive youth development approaches will improve their employability.

While the project management regularly adapts on the basis of research and learning insights, the transmission of these insights into the orientation and action of local and national authorities is lacking a dedicated mechanism. What is more, the timeliness of commissioned research and formal learning events cannot adequately account for the fast-paced evolution of context dynamics in the Bounkani region. This Early Warning & Action Mechanism will allow the project to address these two gaps by generating data on context trends at a higher frequency and embed spaces for analysis and action within the local and national authorities.

### **Objectives**

### General objective:

The Early Warning (EW) & Action Mechanism will empower local and national authorities as well as communities in the Bounkani region to identify quick evidence-based actions to respond to the evolution of the context as relates to violent extremism

### Specific objectives:

- a) Identify how community resilience to violent extremism manifests concretely in daily lives
- b) Ensure buy-in and ownership of the EW Mechanism by local and national authorities
- c) Build on and strengthen existing R4P local networks and partners
- d) Ensure public access to collected data while ensuring conflict sensitivity
- e) Facilitate uptake of actionable recommendations by national and local State authorities as well as the R4P project

#### Thematic focus

The context monitoring through the Early Warning & Action Mechanism focuses on dynamics linked to community resilience against violent extremism in line with the R4P objectives. More specifically, this can include, but is not limited to incidents and perceptions concerning:

- Violent extremism
- Community resilience against violent extremism
- Human security
- Social cohesion
- Local governance

The thematic focus will be adapted through the co-creation process with stakeholders.

### **Process and activities**

The following process description is indicative and can be adapted for the actual proposal. Any approach must reflect community-owned, participatory and conflict sensitive approaches in order to be considered.

- 1. What to look at: Identify the indicators for community resilience against violent extremism that are specific to the Bounkani region and can concretely inform local stakeholders' understanding and action. To ensure local relevance, this should be done through a co-creation process with local stakeholders.
- 2. Whom to work for: Engage with local and national State authorities to ensure their buy-in and ownership of the indicators and data collection method and system to allow for sustainability beyond the life of the project. These include, among others, the National Security Council (CNS), the National Border Commission (CNFCI), the National Center for the Coordination of Early Warning Responses (CNCMR), Conseil Regional of the Bounkani region, Ministries of Interior and Defense and others concerned). This engagement process includes the setting up of an advisory committee composed of these stakeholders.
- 3. **How to get the data**: Set-up a system of data collection that is community-based and conflict sensitive as well as builds on and integrates existing R4P networks and partners.
- 4. **How to access the data**: Set up a system to allow public access to collected data. This includes an interactive public online platform with the capacity to geolocate information and produce visualizations.
- 5. What to do with the data: Provide analysis of data through formulation of key insights and actionable, targeted and location-specific recommendations for local and national authorities as well as the R4P project. Ensure mechanisms that facilitate the understanding and uptake of these insights and recommendations.

May 2022 – June 2022: Set-up of data collection system, buy-in of authorities

July 2022 – February 2023: Data collection, analysis, recommendations, uptake

### **Supervision and collaboration**

The contractor will report to the COP of R4P and will work in coordination with R4P's Action Research Unit (EAI, NORC, Indigo-Côte d'Ivoire, Chaire UNESCO de Bioéthique). R4P will ensure the uptake of recommendations into its community actions. R4P will inform the monitoring process through research studies and project reporting.

# **Proposal Requirements**

  - b. Submit copies of required licenses to operate in-country.
  - c. Implementation plan, including timeline
  - d. Management structure and qualification of key personnel/partners
- c. Financial proposal
  - a. Clear and concise budget with categories down (car rental, per diem, hotel, etc.)
