### 4. Attachment B: Scope of work

Development of an Index on Community Resilience against Violent Extremism in Northern Côte d'Ivoire

#### Context

Resilience for Peace (R4P) is a five-year USAID-funded, EAI-implemented, initiative to strengthen community resilience and learning, particularly for women and youth, to counter and prevent violent extremism in Côte d'Ivoire's northern border areas. Working with partners – National Opinion Research Center (NORC), Indigo-Côte d'Ivoire and Chaire UNESCO of Bioethics at the University Alassane Ouattara – the project will foster a "CVE ecosystem" by reinforcing community resilience structures, creating civic and economic empowerment opportunities for at-risk border communities, and through improvements in natural resource management and government-service delivery and responsiveness.

The Resilience for Peace project has generated a rich understanding of the local dynamics around community resilience against violent extremism and has adapted its theories of change around its main action components accordingly. The current theories of change will guide the main investments of the project in subsequent years. Rigorous testing of these theories through sophisticated quantitative methods would provide the necessary evidence to confirm or further adapt the central theories of change. Beyond the project itself, the resulting program priorities will be important evidence-based guidance for policy debate and synergies with other interventions.

#### **Objectives**

### General Objective:

The Violent Extremism (VE) index will devise concrete, context-specific strategies for action for R4P and the Ivorian government to effectively reinforce community resilience against violent extremism based on opinions and attitudes of populations living in the northern border area of Côte d'Ivoire.

#### Specific objectives:

The VE Index will clearly define:

- a) What we are talking about: Clearly conceptualize and operationalize the notion of "community resilience against violent extremism"
- b) What the key vulnerabilities are: Generate evidence-based understanding the root causes and current key drivers of vulnerabilities to violent extremism
- c) What resilience factors to invest in: Identify which assets and resources at the local level are important to strengthen the capacity of a community to resist to and manage the risks of violent extremism (resilience)

- d) Which target group to focus on: Identify target groups (along the lines with sociodemographic and/or attitudinal characteristics) at risk of violent extremism as well as those particularly well placed to carry positive resilience initiatives in order for programming to be more targeted.
- e) Which theory of change to invest in: Test and adapt the central theories of changes of R4P programming through evidence-based causation analysis
- f) **Ensure stakeholder ownership**: Ensure that stakeholders of the northern border areas of Côte d'Ivoire (community leaders, civil society, local authorities, national government actors, international partners) have a joint understanding of the priority entry points for programming and policy to strengthen community resilience against violent extremism.

#### Thematic focus

The Index focuses on community resilience against violent extremism in line with the R4P objectives. This notion can be composed of the following, non-exhaustive, dimensions:

- Violent extremism
- Governance
- Human security
- Social cohesion
- Life skills

The thematic focus will be adapted through the co-creation process with stakeholders.

### Geographic scope

Resilience for Peace works in all five administrative regions bordering Burkina Faso and Mali with eight departments directly covering project activities: Minignan, Kaniasso, Tengrela, Férkéssedougou, Kong, Téhini, Doropo, et Bouna.

This index is considered a pilot with limited geographic scope. If successful, the contract may be extended for the following year. The project suggests focusing on the three departments at the northern border area of Minignan, Kong and Tehini. The final scope and choice of geographic focus is subject to discussion and agreement. The applicant can propose an alternative geographic focus by providing relevant arguments.

#### **Process and activities**

- 1) Conceptual design of subject matter and measurement tools in consultation with R4P and stakeholders
- 2) Setting up advisory committee with internal and external stakeholders
- 3) Testing and calibration to local realities in the selected departments and to stakeholders' needs concerning policy and programming orientation in collaboration with national research partners

- 4) Data collection through quantitative survey in collaboration with national research partners. The service provider will cover all costs related to data collection, including management of enumerators
- 5) Data analysis (statistics)
- 6) Development of concrete recommendations with and for stakeholders for policy and program responses
- 7) Documentation of data results, analytical insights and co-created recommendations

### **Key deliverables**

- Note on the design of the study and its methodology as well as implementation plan
- Report from the results of the testing and calibration phase
- Raw data from survey
- Report of results including
  - o Graphics on descriptive statistics
  - Heatmaps on geographical results
  - o Predictive models showing causalities
  - Disaggregation by socio-demographic profile and particular response patterns whenever relevant.
  - o Recommendations for action
- Presentation of results to R4P, USAID and key stakeholders in person and via online session

### **Timing**

This first contract is for six-months to run a pilot in key geographical areas to test the viability of a larger-scale VE index for Cote d'Ivoire. The anticipated timing is July – December, 2022.

#### **Timeline**

June 2022: Conclusion of contract

July 2022: Start of work

November 2022: Presentation of (preliminary) key findings at annual learning summit

December 2022: End of pilot (this contract) activities (6 months from July – December)

January 2023: Submission of final report

#### **Supervision and collaboration**

The grantee will report to the project's Chief of Party (COP) and will work in coordination with R4P's Action Research Unit (EAI, NORC, Indigo-Côte d'Ivoire, Chaire UNESCO de Bioéthique). R4P will ensure the uptake of recommendations into its community actions. R4P will inform the monitoring process through research studies (qualitative and quantitative data) and project reporting.
